Subject: Professionalism

The School of Medicine (SOM) and VCU Health System are committed to a culture of professionalism essential for the highest standards of patient care and safety, medical education, research and research training. To remind us of that commitment, enclosed are:

- Pocket card containing our SOM "Standards of Professional Behavior." We suggest you keep the card in your pocket and refer to the "Standards" at appropriate opportunities as we teach, learn, deliver safe patient care, and conduct research. Pocket cards are given to students, housestaff, and faculty, and the standards are incorporated into courses, clerkships, training programs and evaluations. The standards were recently revised to include expectations for communications via electronic/social networking technology.

This process is meant to be informal and confidential, with consultation provided by members of the SOM Professionalism Committee, as an alternative to other routes for reporting concerns.
